FULLY VIRTUAL 9TH ANNUAL GENERAL MEETING

The 9th AGM of the Company will be conducted fully virtual through **live streaming from the online meeting platform** and online remote voting via the Remote Participation and Voting ("**RPV**") facilities via TIIH Online provided by Tricor Investor & Issuing House Services Sdn. Bhd. ("Tricor") via its website at https://tiih.online.

GENERAL MEETING RECORD OF DEPOSITORS ("ROD")

For the purposes of determining a member who shall be entitled to attend the 9th AGM, the Company shall be requesting a General Meeting ROD as at 26 May 2023. Members whose names appear in the General Meeting ROD shall be entitled to attend, participate, speak and vote at the 9th AGM or appoint proxies or corporate representatives to attend and/or vote on their behalf.

REMOTE PARTICIPATION AND VOTING FACILITIES

Shareholder(s) or proxy(ies) or authorised representative(s) or attorney(s) are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 9th AGM using RPV facilities provided by Tricor via its TIIH Online website at https://tiih.online.

A shareholder who has appointed a proxy(ies) or attorney(s) or authorised representative(s) to participate at this 9th AGM via RPV facilities must request his/her proxy(ies) or attorney(s) or authorised representative(s) to register himself/herself for RPV facilities at TIIH Online website at https://tiih.online. If you have any question for the Chairperson/Board of Directors ("Board"), you may use the Query Box to transmit your question. The Chairperson/Board will endeavor to respond to questions submitted by remote participants during the 9th AGM. If there is time constraint, the responses will be published in the corporate website earliest possible, after the meeting.
е.	Online remote voting	 Voting session commences from 11.00 a.m. on Friday, 2 June 2023 until a time when the Chairperson announces the completion of the voting session of the 9th AGM. Select the corporate event: "(REMOTE VOTING) LEONG HUP INTERNATIONAL BERHAD 9th AGM". Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
f.	End of remote participation	Upon the announcement by the Chairperson on the closure of the 9 th AGM, the live streaming will end.
